#### BCNA March 13, 2017 Meeting Summary By Carol Medaris

Kirk Elliott called the meeting to order a bit after 6:30. He announced that Jane Smith has volunteered to facilitate our next meeting.

Committee reports:

**Contact**: Bob Stoffs reported that Make Music Madison is scheduled for Wednesday, June 21. Neighbors are encouraged to participate and to provide venues.

**SMPC Liaison**: Carrie Rothburd reported on the visioning process that took up much of the last SMPC meeting, and said she felt that an expanded public input process was needed.

FOOT: Andria Blattner reminded us that the next Bird and Nature walk will be April 9th. There will be a Bird and Nature Festival on May 16th, starting at 1:00 with a variety of activities including a live raptor presentation beginning at 1:30. FOOT will have a table at the festival. The concerts in the park will begin a bit later in the season this year. Also, Ron Shutvet and Andria have begun meeting with the Madison Parks Conservation Committee.

Friends Of Monona Bay: Andria Blattner and Lisie Kitchel announced a meeting on March 30th regarding the dredging of the Bay near the Parr Street intersection. It will be at the Goodman Library from 6:30 to 8:30. The dredging was initially planned to make way for a second off-loading site for county weed-cutters. Now an expansion of the area is being discussed to address additional problems with sediment in an adjacent area. Anyone interested may attend.

**Newsletter:** Judy Robinson announced that the deadline for copy is this coming Friday, March 17, and delivery is scheduled for the first week in April. (In response to a report of a delayed delivery, Kirk said he would look into that.)

**Treasurer**: Judy reported that ad revenue for the year was \$2,573 and that for dues it was \$208. She will provide a written report at our next meeting for approval, as is now required by our by-laws. In response to a question about the ash tree fund, she said that there is currently \$221 left over from the last treatment which will be put toward the \$800 charge for the next treatment, due in three years.

#### **Planning & Economic Development:**

Carrie Rothburd began her report and Ron Shutvet raised the issue of adequate notice to those who had expressed interest in being on the committee. As we began to discuss how best to notify and then include all those who wish to participate, it became clear that this discussion required more space so we postponed the discussion until after election of officers.

Elections: In addition to BCNA officers, chairs of standing committees and area representatives are elected each year. Positions are usually filled by encouraging volunteers. Judy announced that the Area 3 Representative had moved out of the area; since no one volunteered for that position, it will remain open. Bob Stoffs announced that he wished to withdraw from being the BCNA Contact, and Jim Kreft volunteered for that position. There were no other volunteers for any position, and with those currently holding the remaining positions agreeing to continue, the entire slate was approved with the two changes. (See last page of the Bulletin for a current list.) A shout out to Bob Stoffs for all his years of service to the BCNA.

#### **Planning and Economic Development Issues:**

Carrie reported that the proposed supportive housing for homeless residents at 1202 S. Park St. was submitted to WHEDA in early March; no further action is expected until tax credits are decided. She also reported that the Jade Garden development is on indefinite hold.

Regarding Wingra II, Carrie described how T Wall's proposal was again at 5 or 6 stories, under pressure from the city to increase size and density. The developer's previous proposal—a four story structure with an entrance off Park Street—was more in line with what members had seemed to prefer when we discussed this at our last meeting. At that point Ron raised the issue of decision—making procedures as well as the notice and participation issues relative to the P&ED Committee that he raised earlier in this meeting. Subsequently, tempers flared and the P&ED report and discussion on Wingra II ended prematurely.

Alliant Energy Center Development: County Board Supervisor Richard Kilmer reported that a new AEC Strategic Design Study Committee, with Hunden Strategic Partners, has replaced the old AEC Commission, and is submitting new preliminary plans to develop the area with an estimated cost of \$250 million. Public meetings are anticipated. Richard will keep us apprised of these. Please see update on Page 2. (Continued on Page 3)

# **BCNA Meeting Summary, Continued Review of Tax Incremental District (TID) #42**: On

March 11, Ron Shutvet met with Sara Eskrich, who has agreed to meet with city staff to inquire about establishing a committee to review TID #42, created in 2012, and covering the Park Street corridor from Delaplaine Court to the tracks south of Wingra Creek. Tom DeChant, neighbor and member of the City's Urban Design Commission was out of town, but it is hoped he can join them in further preliminary discussions. In broad outlines, the review would seek to preserve the best options for land use and transportation improvement in the coming years, with input from current businesses and landowners as to future plans and with an eye to various existing plans for this area.

The meeting was adjourned around 8:15.

# Planning and Economic Development Committee Report By Steve Davis & Carrie Rothburd

Jade Garden – There are no recent updates. The development team either is exploring options per its last response to P&ED about two months ago or has given up the project per its communication of the same time with the Wisconsin State Journal.

Heartland application for permanent housing for homeless individuals – The application to WHEDA was submitted on March 3, 2017, and WHEDA will likely make its selections available in early June. According to the city, there will be opportunity for neighborhood input on the plans for Heartland's proposed development only after they have been selected by WHEDA.

Alliant Energy Center -- Hunden Strategic Partners', planners for the AEC site, released their draft report for redeveloping the 164-acre site on March 9, 2107. The team has not included public input in its planning process. It anticipates doing so at some point in the future.

Park Street Corridor Planning Process – P&ED along some neighbors and Alder Eskrich have requested assistance from City neighborhood planning staff for future planning on South Park to avoid new developments creating "on-the-ground," facts that constrain future options. We have asked Alder Eskrich to join with us in stressing to the city that Park is a complicated street with totally different realities block by block that need to be taken into account when planning and that this is best achieved through proactive planning with neighbors.

Wingra Creek Residences – T. Wall Enterprises' development team will take its draft renderings to the Urban Design Commission on March 22, 2017 for feedback and not a vote. These plans show: 1) a 5+-story point structure that is largely glass; 2) a garage entrance located on South Street; and 3) reduction of the south building height to 4 stories; and 4) reduction of the plaza height at the north end of the building. Several neighbors submitted a place-making proposal to the city that included common space at the plaza and in the buildings' lobbies to reflect the site's rich history in Bay Creek as Bancroft Dairy.

Conversation with the candidate – A number of neighbors asked P&ED to bring questions to our alder who is running for reelection unopposed. We have passed those questions along to Sara and will post her responses either online or to the listserv/Facebook page about two weeks before the election.

#### **Alliant Center Update by Richard Kilmer**

Background: In 2016, the Dane County Board authorized a master planning process for the development of the Alliant Energy Center (AEC). The study was done by Hunden Strategic Partners, a Chicago consulting group. The plan by Hunden recommends adding hotels, commercial space and remodeling the existing coliseum building. This plan by Hunden would be less expensive than the earlier \$500 million plan by the Hammes Co. which recommended tearing down and replacing the Coliseum.

My concern as the County Board Supervisor for our neighborhood is that the plan done by Hunden does not include enough input from residents and should include more feedback from neighbors in Bay Creek and Bram's Addition.

To help accomplish that, there will be public meetings of AEC Strategic Design Study Committee. The Committee will invite community feedback before making a recommendation on the master plan. Information on the meetings will be posted on baycreekmadison. org and in the newsletter if the timing allows.

### Free Trees for Bay Creek By Jeremy Kane

The Urban Tree Alliance (UTA), a Madison based not-for-profit, is offering free trees to residents in the Bay Creek neighborhood. This effort is part of the ongoing Madison Canopy Project, a program intended to grow and diversify Madison's urban forest canopy. Approximately 15 varieties of trees are available to suit diverse growing conditions. Trees are generally two years old and range from 4 to 7 feet tall.

The UTA will distribute information about the Madison Canopy Project door to door over the coming months. Anyone interested in the program can find more about the program, or request a tree, by visiting the UTA website (urbantreealliance.org) and searching under the Programs heading. Residents can also call 608-556-5331. The first step is to make a formal tree request. We then follow-up to visit the property and confer with the landowner about which trees would be appropriate and preferred. We can either provide the tree or plant it.

The Madison Canopy Project is focused on increasing canopy coverage on private properties, but the UTA is a resource for a wide array of urban forestry issues. Please feel free to contact us with questions or thoughts about the program. Meanwhile, keep an eye out for us over the coming months. We look forward to working in Bay Creek and planting some trees.



# **FOOT Notes**By Andria Blattner

So far this year has been a blur and a jumble and the weather has been no exception. One victim was the traditional Candlelight Ski – no snow and the ground was a muddy mess. This was something we never expected to deal with in February. It is really hard to know what effect this erratic weather is having on our native plants and wildlife. But the overall warming is allowing many southern species, like the Opossum to move north.

There will be some interesting consequence of these migrations. Some might actually be good, such as the regulation of diseases spread by ticks, like Lyme's. Opossums are much more efficient than mice at keeping ticks from attaching; 50% will attach on mice but only 3.5% will attach on opossums. And moreover while grooming they eat all the ones that don't attach. It is estimated that opossums can remove up to 5,500 ticks from the population. (Who can't love a critter that said "We have met the enemy and they are us".) This is enough to effectively keep down the transmission of diseases to people, dogs and other animals. Any migration and change of populations will definitely cause changes to the existing balance, usually causing harm, like the many invasive species we are experiencing.

The next nature walk in Turville Point will be on Sunday, April 9. It will be led by Chuck Henrikson, a very enthusiastic and knowledgeable birder. The wild flowers will be making their first showing. There was a big patch of Snowdrops and a few blue Scylla already blooming in Turville. The May 14 walk will be led by Paul Noeldner.

Sunday, April 16, from 1-4 p.m. is the Bird and Nature Festival. This event celebrates birds, nature and the fact that Madison is a "Bird City". The featured presentation is "Wild Birds of Prey" with live Raptors. The speaker is Elise Schuler of the Raptor Education Group, Inc. (REGI) in Antigo, WI. The event is in Warner Park at the "Rainbow" Shelter. This event is sponsored by the Friends of Urban Nature and cosponsored by City Parks. There will also be Tree climbing, Hayrides, Food Carts, Music, Bounce House, Arbor Day Tree Planting, face painting, Nature Group Exhibits, Kids Games and Nature Activities and of course an Easter Egg hunt!

Well, let's hope for a good spring and no late freezes to kill the blossoms and thus fruit. Hope you can get out and walk around the neighborhood.

# Rain Garden Initiative (Courtesy of Friends of Lake Wingra)

It's almost spring; which is a lovely time of year to appreciate the birds and the bees and maybe spend some time in the garden. If you love your garden – or the local lakes for that matter – you should consider installing a rain garden this spring.

A rain garden is specially designed to collect rain water and clean it before it reaches the lake. When rain water washes through streets, parking lots, and over roofs it collects all kinds of dirt and chemicals. If that water goes directly into the storm drain, then it ends up right in the lake – along with all that grime. A rain garden filters the water so that by the time it reaches the lake it's fresh and clean. What's not to love – fresh flowers and fresh water!

At Friends of Lake Wingra, our goal is to install 1,000 rain gardens in neighborhoods where storm drains lead to Lake Wingra. We know that clean water is key to maintaining the health of all the plants and animals that live in the area. Not to mention, to keeping the lake a place that is pleasant for boating, fishing and swimming.
